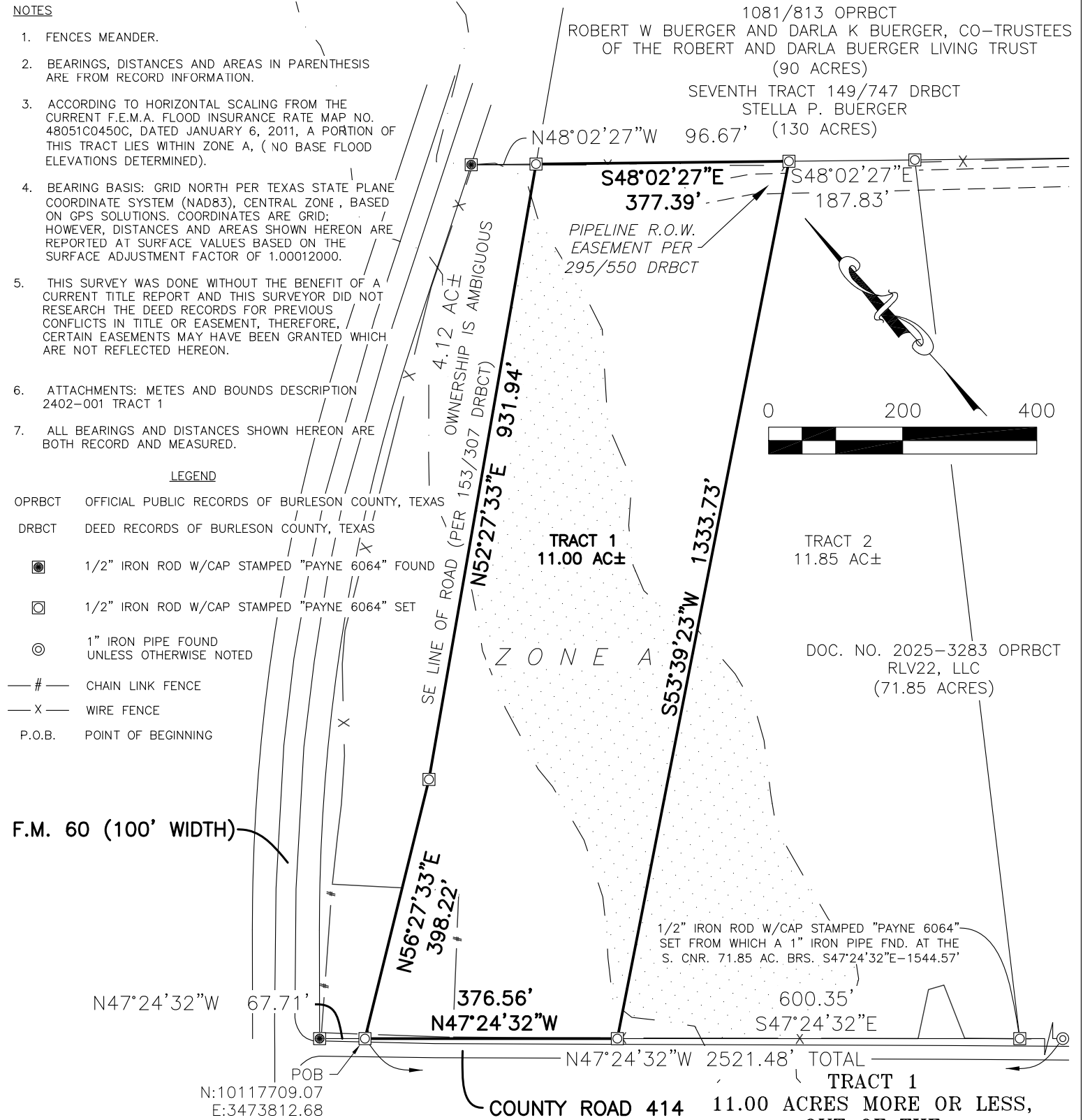
1. FENCES MEANDER.
